COMPETITION TERMS AND CONDITIONS OF ENTRY

1. Information on how to enter the competition, prize details and other information contained within the promotional material forms part of these terms and conditions of entry. Participation in this competition constitutes acceptance of these conditions of entry.
2. This competition is being run by Lynbrook Village Shopping Centre of 75 Lynbrook Boulevard, Lynbrook VIC 3975 (the 'Centre').
3. Customers may enter the competition by making a purchase at any Retailer at the Centre and completing an entry form which can be obtained from any Retailer at the Centre. Customers must retain original receipt/s to validate their purchase should they win. Photocopies and facsimiles of receipts are not valid. Full name, phone number and any other required contact details must be stated clearly on the entry form.

The following transactions are excluded: Partial lay-by receipts, bill payments such as the payment of credit card bills, bank transactions, receipts for prescription medicine/s, bank fees and charges and service bills (such as gas, electricity, rates, and phone bills) are not accepted as part of this competition.

9. Officers, employees and immediate families of officers and employees of the Promoter, the associated companies and contractors of the Promoter, retailers and staff at the Centre and any other agencies associated with this competition are ineligible to enter.

The Promoter reserves the right to verify the validity of entries or claims for the Prize and reserves the right to disqualify any entrant for tampering with the entry process or for submitting an entry of claim for a prize which is not in accordance with these terms and conditions.
